All Exhibitors / Site Holders intending to bring electrical equipment to the Show ground will be required to ensure that such equipment is fitted with earth / leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow Exhibitors / Site Holders and the general public, and is a requirement of the Occupational Health & Safety Act of 1983. The Act imposes very severe penalties in the event of non-compliance with its provisions. Please check all your electrical equipment and leads before you come to the Show ground to avoid the occurrence of any difficulties. You are required to have a current Public Liability of \$10 million (or more). A copy of your Certificate of Currency must be produced prior to setting up.
